PAGE 2 AFFIDAVIT

The undersigned, being duly sworn, deposes and says:

Detectives Vazquez and Harrison did conduct an interview with one of the females who was injured at the time of this incident. The eyewitness stated that she knew one of the subjects firing on the crowd as Lamont and has known him for approximately four (4) years. The eyewitness stated that she was positive that Lamont was one (1) of the two subjects that was firing at the crowd.

This affiant identified Lamont as Lamont Swint whereupon the eyewitness positively identified Lamont Swint from a photo array as the subject that discharged his weapon at the crowd in front of 33 Dickerman Street. The eyewitness signed and dated photograph and provided a tape recorded statement to detectives.

The Honorable Judge Fischer granted a search warrant for the premises of 123 Newhall Street, the home of Swint which yielded mail evidence that Swint resides there. No other evidence was seized.

Detectives located Swint outside his home and he agreed to come to the NHPD. There he waived his Miranda rights and provided detectives with a taped statement in which he detailed the actions of himself and three accomplices in the shooting of Jajuana Coles on Dickerman Street. Swint admitted to being present and witnessing Daniel Carter and Tremaine Sanders shooting into a group of young people. Swint denied possessing a firearm that night but said in taped statement that he was aware that Daniel Carter and Tremaine Sanders were armed and that following the shooting, Torell Boyd drove the suspects from the area. Swint said that the guns used in the commission of the murder are stored at Daniel Carters home. Furthermore, Swint rode with detectives and pointed out Carter's home at 372 Shelton Avenue.
