

PAGE 4 AFFIDAVIT

The undersigned, being duly sworn, deposes and says:

Sanders, Swint, Carter and Boyd. They were in possession of a video camera and were being driven around the city by Torell Boyd. They drove down Dickerman Street and as they passed 33 Dickerman Street, they observed Jeffery Franklin standing in front. Franklin is apparently a member of a rival neighborhood gang. Upon spotting Franklin, Carter said "there go some of them." Carter then instructed Boyd to circle the block and park on Goffe Street. On Goffe Street, Boyd parked the car in the lot of an apartment building. The juvenile, Carter, Sanders and Swint exited the car and walked through the rear yards to Dickerman Street. Boyd remained with the vehicle. The juvenile said he was the operator of the video camera and was walking with Swint and following several yards behind Sanders and Carter.


The juvenile saw Carter carrying in his hand a chrome .380 caliber handgun and knew Sanders was armed with a black handgun. As Carter and Sanders reached the front of 33 Dickerman Street, The juvenile says he and Swint stood by a large dumpster and video taped Carter as he opened fire. The juvenile said he did not recall seeing Sanders fire his gun. All three reconvened at Boyd's car and as they left the area, The juvenile heard Carter say, "I think I shot one of the girls."

The juvenile signed photoboard of Swint and Sanders as proof of his identification of his accomplices. Carter and Boyd were positively identified using year book photos from Hillhouse High School. The juvenile further viewed still photographs made from the videotape. He again identified his accomplices and signed those photographs as well as providing a taped statement.
