Wallingford Ct. D.O.B 12-11-83 he began taking pictures and filming. Asst. Chief Melendrez approached Mr. Luna and asked him to leave as well as stop filming. Mr. Luna did not do so. Therefore, Chief Melendrez instructed me to arrest Mr. Luna. I did handcuff him and conduct a pat down - Mr. Luna was placed into the prisoner conveyance vehicle and transported to I-Union Av for the charge of interfering. His bike a grey 'Trek' was brought to I-Union Av. and placed into evidence at I-Union Av.
