KNOW ALL TO WHOM THESE PRESENTS SHALL COME OR MAY

CONCERN, JENNIFER GONDOLA (the "Releasor") does, on behalf of herself, her successors, heirs and assigns, in consideration of the payment of the sum of Thirteen Thousand Dollars (\$13,000.00), herewith releases and forever discharges the City of New Haven, Police Chief Dean Esserman, and Police Officers Christopher Rubino, Curtis Miller and Nikki Curry, its and their agencies, agents, officials, and its former or current employees, (the "Releasees"), from all actions, the results of said actions, causes of actions, suits, claims, controversies, that he may now have or hereafter can, shall or may bring against said Releasees, and from all injuries and damages of every nature and name suffered by him, or for which he might be entitled to compensation, in law or in equity, including attorney's fees and costs, from the beginning of time to the present date of this Release, arising from a certain incident that took place on or about June 2, 2012, where it is alleged that Jennifer Gondola's civil and constitutional rights were violated.

It is agreed and understood that the Releasor, JENNIFER GONDOLA, shall not attempt to use this Release, or the facts and evidence underlying the above mentioned lawsuit, against the Releasees, or against any agency, agent, official, former or current employee of Releasee City of New Haven, in any pending or future legal proceeding of any sort.

Additionally, in consideration of the sum indicated above, the Releasor further agrees to indemnify the Releasees and save them harmless from any and all further liability, loss, damage, claims of subrogation and expenses, because of any injuries and damages allegedly sustained by the Releasor as a result of the incident described in the above mentioned legal action, and if necessary, in order to save them harmless, to satisfy on their behalf any judgment against the Releasees.

It is expressly understood and agreed that the payment of the aforesaid sum is NOT an admission of liability on the part of any of the Releasees, or by any agency, agent, official, former or current employee of the Releasee City of New Haven, except to any admission, if any, made by any of the Releasees in any other court proceeding that would bear on the claims of the Releasor, but rather constitutes a compromise settlement of any and all claims made, or that could have been made, by the Releasor JENNIFER GONDOLA in the above mentioned lawsuit.
