PAGE 1 AFFIDAVIT

The undersigned, being duly sworn, deposes and says:

That the undersigned, Detective Al Vazquez is a member of the New Haven Department of Police Service and has been a member of said Department since January 21, 1992. At all times mentioned herein was acting as a member said department. The following facts and circumstances are stated from personal knowledge and observations as well as information received from brother officers acting in their official capacity and from police reports and statements made by prudent and credible witnesses.

On June 16, 2006 at 11:18 p.m. members of the New Haven Police Department responded to the area of 31-35 Dickerman Street on report of a person shot. Upon arrival Officers located three black females suffering from gunshot wounds. JaJuan Coles, (dob 05/01/1993) was found unresponsive and suffering from a single gunshot wound. She was transported to Yale New Haven Hospital and later pronounced dead as a result of her gunshot wound. The two other black females, who suffered minor gunshot wounds, were medically treated and released. Both females were transported to the New Haven Police Department and interviewed as eyewitnesses to the shooting.

General information obtained from eyewitnesses at the scene stated two to three black males ranging between the ages of 16 to 19 years of age were responsible for the assault. According to eyewitnesses they stated that these subjects took aim with black handguns at a group of young females and males standing in front of 33-35 Dickerman Street and shot approximately 8 to 15 times.
