

PETITION FOR CLARIFICATION

- 2. Local 3144, AFSCME, Council 4 ("L. 3144") is an employee organization within the meaning of the Municipal Employee Relations Act, Connecticut General Statutes § 7-467 et seq. ("Act"). Its address is 444 East Main Street, New Britain, CT 06051.
- 4. That the City and L. 3144 are parties to a collective bargaining agreement ("L. 3144 CBA") having effective dates of July 1, 2005 through June 30, 2010 (Exhibit A).
- 5. That the Local 3144 bargaining unit encompasses supervisory and professional management job classifications and is supervisory and professional in nature.

That following a review and analysis of particular job descriptions 7. and duties currently recognized in the L. 3144 bargaining unit, the City believes that the job titles contained in the attached appendix (Exhibit B) are misclassified.

- 1. That the State Board of Labor Relations review the positions contained in Exhibit B and clarify whether they are appropriately included within the Local 3144 bargaining unit.
- 2. Such other relief as the Board may deem just and proper.
