Action Taken:

The "Street Interdiction Unit" (SIU) is part of the Investigative Services Division in the New Haven Police Department. The primary objective of SIU is to enforce the State of Connecticut narcotic laws as they pertain to the City of New Haven. We also address priority complaints such as robbery, weapon violations and quality of life issues, including motor vehicle enforcement. These officers are clad in plain clothes with police badges around our necks and operate unmarked Crown Victoria police vehicles.

On June 23, 2011 at approximately 1804 hours: dispatch notified fellow brother and sister police officers via police radio that shot spotter had detected one gun shot being fired on Blake St. in between Osborn St. and Diamond St. It should be noted shot spotter is a computerized system that has sensors through out the city that detect gun shots. These officers

where traveling south on Osborn St. approaching Blake St. when we witnessed a tall black male clad in all black, (later identified as Joseph Donaby DOB 05/17/80) walking quickly east on Blake St. crossing Osborn St. I then turned east on Blake St. and stopped adjacent to Joseph Donaby. Mr. Donaby then immediately turned directly at officer Senior and I, making direct eye contact with me, then yelled "oh shit" grabbed at a very large bulging object in his front right waist band area, and began to run east on Blake St. Through my training and experience I know the waist band area is common area where weapons such as guns, and knives are commonly kept in order to conceal them.

Ofc. Senior exited on foot and pursued Mr. Donaby, and gave chase approximately 200 feet east of Osborn St. on the southern most side walk on Blake St. While running east on Blake St. Mr. Donaby attempted several times to remove a very large object which I believed to be a weapon, from his right front waistband area. I drove east on Blake St., along side Mr. Donaby. I pulled my vehicle ahead of Mr. Donaby in attempt to cut off his path of escape, in doing so I struck the fence in front of 96 Blake St. Mr. Donaby jumped over the right fender of the patrol vehicle, and rolled over the hood of the car. After Mr. Donaby rolled over the hood of the car, he entered the front yard of 96 Blake St. and ran towards the rear yard. Ofc. Senior chased Mr. Donaby at which time Mr. Donaby removed a large brown and black firearm from his front right waist band area and continued to run towards a wooden fence bordering the rear yard of 96 Blake St.

At this time officer Senior announced several times, "drop the gun, drop the gun". Mr. Donaby refused to comply and continued to elude Ofc. Senior, he ran with the firearm in his right hand. Ofc. Senior stated that he drew his department issued firearm and ordered Mr. Donaby to drop the gun. Mr. Donaby was approximately 5 feet from the rear fence when he threw the firearm over the fence. Ofc. Senior stated Mr. Donaby attempted to jump over the fence when Ofc. Senior grabbed him off of the fence utilizing his left hand. Mr. Donaby then turned and struck Ofc. Senior in the left shoulder utilizing his right fist. Ofc. Senior stated that Donaby then attempted to grab his department issued firearm, at which time Ofc. Senior holstered his weapon, and pushed Donaby away. Mr. Donaby then ran towards the front sidewalk area where Ofc. Senior and I attempted to apprehend him when he struck Ofc. Senior several times in the chest utilizing his elbows.

Ofc. Senior then drew his department issued Tasor X26 serial # XOO-447621. and gave verbal commands to stop fighting. Mr. Donaby refused to comply at which time Ofc. Senior deployed one five second burst to Mr. Donaby's upper back area. The taser was ineffective. Ofc. Senior and I attempted to apprehend Mr. Donaby when he struck both Ofc. Senior and I in the face and chest. Simultaneously Ofc. Senior struck Mr. Donaby three times in the face with a

close fist while instructing him to "Stop Fighting". Ofc. Senior and I forced Mr. Donaby to the ground at which time Mr. Donaby had kicked and punched me in the right leg, foot and chest area. Mr. Donaby rolled onto his front and immediately put both hands into his front waist band. I feared that Mr. Donaby was reaching for another weapon. These officers continued to remove his hands from his waist band area. Ofc. Senior and I repeatedly announced for Mr. Donaby to give us his hands through out the duration of the fight, which he refused to comply. At this time Mr. Donaby struck Officer Senior in the chest area with his left elbow. Ofc. Senior struck Mr. Donaby three times in the rear of the head. Mr. Donaby then kicked me in the upper chest area. I then struck Mr. Donaby four times utilizing my right knee and foot in the chest and abdomen. Mr. Donaby continued to resist arrest and refused to comply with our commands continuing to reach and remove an unknown object from his waist band area.

Ofc. S. Biros arrived on scene and assisted these officers with apprehending Mr. Donaby. Mr. Donaby sustained an inch and a half laceration to his upper left forehead and was transported to Saint Raphael's Hospital located at 1450 Chapel St. via AMR. Ofc. Senior sustained injury to his right hand, and left wrist. I sustained injury to my right foot. I notified Sgt. N. Marcucio about the about stated incident.

Detective Armistead arrived on scene and secured one .22 cal Weatherby rifle. See Detective Armistead's supplemental report for further details.

Ofc. Senior logged in one spent Tasor cartridge into the evidence located at 1 Union Ave., New Haven, Ct.

Mr. Donaby was charged with Criminal Possession of a Firearm CGS. 53a-217, Carry a Dangerous Weapon CGS. 53-206, (Two Counts) Assault on a Police Officer CGS. 53a-167c, Interfering with a Police Officer CGS. 53a-167a, and Trespass 3<sup>rd</sup> CGS. 53a-109.
