To New Haven Alders;

St. Matthew's is celebrating 100 years of service in the Dixwell Avenue community. We started out on Orchard Street, moved to Henry Street and became chartered as St. Matthew's United American Free Will Baptist Church. In the 1920's the church moved to Webster Street and in the 1930's moved to Charles Street. In 1962 St. Matthew's moved to 400 Dixwell Avenue, where it is currently located.

This church has established many outreach programs such as: a food pantry that serves breakfast, distributes food, clothing and household goods; offer scholarships to high school seniors; provide back-to-school back packs for the youth in the community; support women shelters with toiletries and clothing; a Christmas Tree Ministry for the children of inmates; open its doors for AA meetings; partner with Believe-in-Me Ministry (where the street naming would take place); host a community gathering known as "Family and Friends;" and many others.

St. Matthew's also opens its doors for counseling, weddings and funerals.

With the longstanding relationship that St. Matthew's has had in this community, and the momentous occasion of celebration 100 years, we believe that it would be appropriate to designate the southwest corner of Argyle Street and Dixwell Avenue as "St. Matthew's Church Corner."
