THE SMOKE ALARMS WERE MISSING ON THE 2ND AND 3RD FLOOR. THERE WERE NO SMOKE ALARMS ON THE 1ST FLOOR. THERE WAS A GAS POWERED MOTOR SCOOTER ON THE 1ST FLOOR HALLWAY. RICK STATED OWNER DID NOT HAVE A ROOMING LICENSE AND THEY WOULD ONLY REQUIRE PEOPLE TO VACATE IF MORE THEN 4 PEOPLE LIVED ON EACH FLOOR.
