On March 25th, 2021, noise level readings were collected from various locations across from Paw Haven Pet Care Facility. These readings were collected to determine compliance with the 2006 City of New Haven Code of Ordinances Noise Section.

In reviewing the New Haven Zoning Map for this area, Paw Haven is located in an industrial zoned area (Peck Street is part of a residential zoned area). Per Section 18-75 (3) of the New Haven Code of Ordinances:

(3) No person in an industrial zone shall emit noise beyond the boundary of his/her premises that exceeds the levels stated herein, and applies to adjacent residential, commercial or industrial zones:

Emitter's zone: Industrial Receptor's Zone: Maximum level: Industrial70 dBA Commercial66 dBA Residential/Day61 dBA Residential/Night51 dBA

Based on the results collected on March 25th, 2021, Paw Haven's noise levels are below the City of New Haven Code of Ordinances Noise Section at this time.
